DRIVING NET ZERO EMISSIONS WITH CARBON CAPTURE UTILIZATION AND STORAGE



Why we need to capture Carbon Dioxide? Carbon Capture and Storage (CCS) is a way of reducing carbon emissions, which could be key to helping to tackle global warming.

India is the 3rd largest emitter of CO2 in the world after China and the US, with estimated annual emissions of about 2.6 gigatonne per annum (GTPA). The Government of India has committed to reducing CO2 emissions by 50% by 2050 and reaching net zero by 2070. Globally, power and industry account for about 50 per cent of all greenhouse gas (GHG) emissions. Carbon Capture, Utilization, and Storage (CCUS) encompasses technologies to remove CO2 from the flue gas and from the atmosphere, followed by upcycling the CO2 for utilization and determining safe and permanent storage options, thereby reversing its negative impacts. Enabling circular carbon economy (CCE), the technology helps manufacturers capture carbon at the point of emission, i.e., chimneys, and trap carbon dioxide using a chemical oxidation process, for reuse in the production of fuels (methane and methanol), plastic components, fire extinguishers, pharma, soda ash, food and drinks, building materials and agriculture. The carbon captured is stacked and stored deep inside geological formations such as exploited oil and gas wells.

Challenges faced by CCUS:

Some of the challenges CCUS currently faces in India includes: a. development of sorbents that can effectively bind to the CO2 present in flue gas or the atmosphere, which is expensive, and b. the demand for CO2 is limited compared to the vast amount of CO2 that needs to be removed from the atmosphere, to reduce the detrimental environmental impacts of climate change.

CCUS- Global Scenario:

Globally there are about 21 CCUS facilities, with a capacity of capturing about 40 MTPA of CO2 or only 0.1% of the 40 GTPA global annual GHG emissions. The first CCUS projects started in the 1970s and 1980s in Texas for capturing CO2 from natural gas processing plants and supplying it to local oil producers for utilizing the CO2 for Enhanced Oil Recovery. Since then, CCUS has spread to other regions and countries, viz. Norway, Canada, Australia, Brazil, Canada, China, Saudi Arabia and the United Arab Emirates.

What are Carbon Credits? A "carbon credit" is a tradable certificate. More specifically, it is a permit that gives the holder the right to emit, over a certain period, carbon dioxide or other greenhouse gases e.g. methane, nitrous oxide, or hydrofluorocarbons. 1 carbon credit corresponds to 1 metric tonne of carbon dioxide prevented from entering the atmosphere.

Buyers and sellers can also use an exchange platform to trade, which is like a stock exchange for carbon credits. In some cases though, it can happen that it is cheaper to pay a fine than to buy carbon credits due to their high price.



Chennai-based Sanmar Group arm, Chemplast Sanmar, is planning a Rs. 680-crore capex infusion into its Custom Manufactured Chemicals (CMC) Division.

- The government has set up a task force under the aegis of Fertilizer Association of India (FAI) to find out ways to improve the quality of Single Super Phosphate (SSP) Fertiliser and promote its use as an alternative to Diammonium Phosphate (DAP), Parliament was informed recently.
- Revalyu Recycling (India) Ltd. has announced the start of construction of a 200-tpd (tonnes per day) Polyethylene Terephthalate (PET) Plastic Recycling Plant.
- Crop Care Federation of India (CCFI) the largest manufacturers and exporters of agrochemicals while while appreciating the proposed changes in budget have reiterated that the present GST of 18% on Pesticides should be maintained as all the raw material, packing material, containers, Plant & Machinery levy GST of 18%.
- The Board of Directors of SRF Ltd. has approved a project for setting up a range of specialty Fluoropolymers at Dahej, Gujarat, at a projected cost of Rs. 595-crore.
- Meghmani Finechem Ltd. (MFL), a leading integrated chemical manufacturer, has announced that it will be raising its chlorinated polyvinyl chloride (CPVC) resin capacity to 75,000-tpa, by adding another 45,000-tpa of capacity.
- Gujarat-based Meghmani Organics Ltd. (MOL) has announced the commissioning of its Titanium Dioxide (TiO2) Plant at Dahej, Gujarat. The plant came into MOL's fold with the acquisition of Kolkata-based Kilburn Chemicals Ltd. in December 2021.
- Horizon Industrial Parks, a logistics and industrial parks specialist owned and managed by Blackstone Real Estate funds, has started construction of a 'build-to-suit' manufacturing facility for British construction chemicals firm, Fosroc. The facility will sit within JCK Horizon Industrial Park Kothur, in Hyderabad, which spans 45 acres and has 1.3 million square feet of development potential.
- The overall Ethanol production capacity in India is expected to go up by 25% to 1,250-crore litres by the end of this year, as proactive steps have been taken for faster clearance of the Projects.

- Snowman Logistics, India's leading integrated temperature-controlled logistics service provider, opened its first-ever state-of-the-Art A-Grade dry warehouse for the chemical industry in Shoolagiri, Tamil Nadu.
- The Alkali Manufacturers Association of India (AMAI) is organizing a conference on 'New Developments in Chlor-Alkali industry" and a concurrent exhibition on 16-17 March at Vadodara, Gujarat.
- LANXESS Performance Materials, a leading global joint venture established between LANXESS and Advent International for high-performance engineering polymers presented a range of modern and light weight solutions with high-performance plastics for the automotive, two-wheeler and e-mobility industry at PLASTINDIA 2023.
- The Board of Directors of Gujarat Alkalies and Chemicals Limited in their meeting held on 7th February, 2023 has granted in-principle approval for 'Vision 10K+ 2028' for achieving annual revenues of more than Rs. 10,000 crore by 2028.
- A Perspective Plan (PP) prepared by the Indian Chemical Council (ICC), the Premier Association for the diversified chemical industry here, sees the Indian chemical market – setting aside pharma products, medical devices and personal care consumer products – grow from its present size of between \$110-bn and \$115-bn to a range of \$600-bn to \$700-bn by 2040.
- Surat-based maker of speciality chemicals, Aether Industries, has announced that it has acquired new industrial premises, located at GIDC Industrial Estate, Sachin.
- To ensure that the domestic industry doesn't raise concerns relating to the implementation of the Quality Control Order (QCO) for 10 identified chemicals, including Morpholine, Acetic Acid, Ethanol and Acetone, on the scheduled dates in February and March, 2023, the Department of Chemicals and Petrochemicals has sought industry comments on the enforcement dates, according to a report in the Hindu Business Line.
